- identify and minimize the risks for the safety and health of all interested parties and for the protection of the environment, in relation to the knowledge acquired on the basis of technical progress, possibly acting on the causes that generated them;

- implement a **constant training** and awareness plan in order to involve all staff in the implementation of the Integrated Management System;

- raise awareness among suppliers, including contractors, of goods and services on the contents of this Integrated Policy, in particular on the issue of resource sustainability (marine and plant);

- evaluate the adoption of processes, technologies and materials that allow a correct use of natural and energy resources and prevent / reduce possible environmental impacts (production of waste, GHG emissions, use of plastic), as well as improving the quality of the product;

- elaborate and develop environmental, safety and health **emergency plans**, containing measures and procedures necessary to prevent accidental situations and to limit their effects;

- establish and maintain adequate controls, including **periodic reviews**, to ensure that the principles contained in this Integrated Policy are followed and that the management systems are kept active and appropriate to the company reality;

- ensure that this Integrated Policy and management systems are understood, implemented and kept active at all levels of the organization, involving employees;
